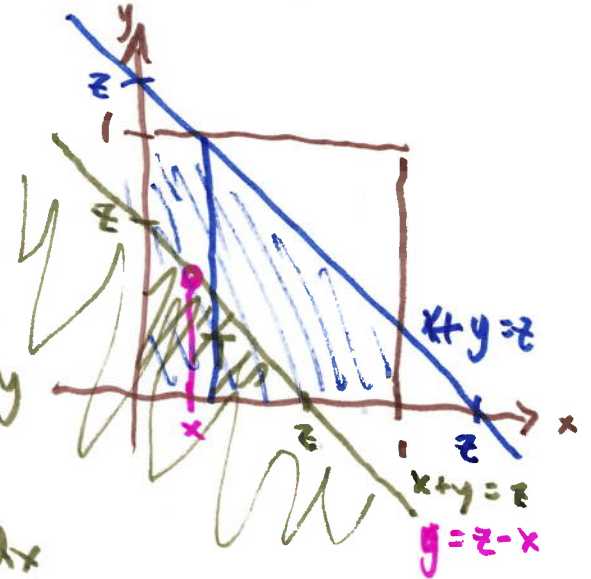


(Example 7.13)

Let X and Y be independent random variables distributed uniformly on $[0, 1]$. What is the probability density function $f_{X+Y}(z)$?

$$f_X(x) = \begin{cases} 1 & \text{if } x \in [0, 1] \\ 0 & \text{else} \end{cases}$$

$$F_{X+Y}(z) = P(X+Y \leq z) = \iint_{x+y \leq z} f_X(x) f_Y(y) dx dy$$



Case 1
 $z \in [0, 1]$

$$\int_{x=0}^z \int_{y=0}^{z-x} 1 \cdot 1 dy dx$$

= area of $\triangle = \frac{1}{2} \cdot z \cdot z = \frac{1}{2} z^2$

Case 2
 $z \in [1, 2]$

$$F_{X+Y}(z) = 1 - \frac{1}{2} (2-z)^2$$

$$\Rightarrow F_{X+Y}(z) = \begin{cases} 0 & \text{if } z < 0 \\ \frac{1}{2} \cdot z^2 & \text{if } z \in [0, 1] \\ 1 - \frac{1}{2} (2-z)^2 & \text{if } z \in [1, 2] \\ 1 & \text{if } z > 2 \end{cases}$$

$$\Rightarrow f_{X+Y}(z) = \frac{d}{dz} F_{X+Y}(z) = \begin{cases} z & \text{if } z \in [0, 1] \\ 2-z & \text{if } z \in [1, 2] \\ 0 & \text{else} \end{cases}$$
